**Aim:** Borrowing from wide range of disciplines, the course aims to develop critical faculties of the students to deconstruct and reconstruct the multitude of contemporary developmental concerns and technocratic participatory governance mechanism. In this endeavour, course hopes to facilitate students in making sense of development discourse at multiple levels in the globalised world. It looks at some of the major theoretical and policy debates on concerns of social justice, liberty, equality, way of life and livelihood and the source of value and happiness beyond the material realm of poverty lines and standard of living. It also looks at the competing and alternative organising principles and institutional mechanism of the development discourse and the kind of everyday practices they engender. Thus, the course hopes to enable the students to understand the politics of hegemonic technologies and their everyday encounter with the bottom billion of the world population.
