Aim: This course explores the complex dimensions of the transition in India from the late Mughal period to the ascendancy of British power till the revolt of 1857. It has two main components. While it traces the trajectory of the processes of British colonization of India, it also seeks to throw light on the varied experience of colonialism by the subject population. It begins with the debates on the decline of the Mughal Empire and the nature of eighteenth century Indian society. It then discusses the pattern of British conquest of India in the global context of trade, warfare and empire building. It seeks to understand the processes by which the East India Company moved from trade to territorial control. The course gives equal importance to the various aspects of the impact of early colonial rule and the ways in which the subject population of India internalized, questioned and opposed colonial rule. It discusses the nature of popular protests from the eighteenth century till the revolt of 1857.

Brief description of modules/ Main modules:

- 1. India in the eighteenth century: Mughal Empire 'collapse' or 'decentralisation'? The debate on the nature of the 18th c: continuity vs. change, the validity of the notion of the dark century.
- 2. The East India Company: from trade to territorial control.
- 3. The foundations of the colonial state: land revenue systems, early colonial trade, the evolution of the army, judiciary and colonial administration.
- 4. The ideologies of colonial governance: Orientalism, Utilitarianism, Evangelicalism, racism, ideas of improvement and progress, new notions underlying law, justice and private property.
- 5. The emergence of the middle classes in India: impact of print culture and western education, early social and religious reform.
- 6. Protest and Rebellion: pre-1857 tribal and peasant protests. The causes, nature and trajectory of the revolt of 1857.
