Aim: This course shall introduce students to some non-mainstream theories and analysis of capitalism which view it as a historically specific as well as a historically evolving economic system. Theories of a range of thinkers and debates around specific institutions and phenomena historically associated with capitalism will be discussed. The methodological specificities of political economy in its interdisciplinary dimensions will be dwelt upon to establish its distinctiveness from the mainstream straightjacket of economic orthodoxy.

- 2. Marx: Historical Materialism, the capitalist mode and its laws of motion.
- 3. Contending conceptions of capitalism: Marx versus Schumpeter, Weber, etc.
- 4. The state, society and the economy in capitalism.
- 5. Monopoly capitalism and the large corporation origins, nature and significance.
- 6. The international dimensions of capitalism nations and nation-states; development and underdevelopment; colonialism and imperialism; globalization and finance; multinational firms and global production networks.
- 7. Capitalism and crises.
