Opening Remarks of the Vice Chancellor

At the outset, the Vice Chancellor extended a warm welcome to all the Members of the Academic Council.

The Vice Chancellor briefed the members about the following milestones achieved by the University during these unprecedented times.

- Dr. B. R. Ambedkar University is the first State University to implement the SAMARTH (Smarter Automation Engine for Higher Education Institutes) Project. The Samarth is a University Information Management System project designed and developed by the IIC, Delhi University in collaboration with the Ministry of Education (MoE) which aims to implement an automation engine for various universities and HEIs. Samarth has helped the universities to migrate from paper to digital documents, unreliable third party ERP systems to a system which is more secure, reliable and scalable.
- The University had its second cycle of NAAC visit from July 26-28th, 2021 for accreditation. The visit was carried out successfully with the coordinated efforts of all the stakeholders. The Academic Council placed on record its appreciations for the IQAC team.
- 3. For the first time, the University has received a large number of applications for admission to its UG and PG Programmes. This is a significant growth as compared to the earlier cycles. The details of the applications received in UG and PG courses are as follows:

The University is about to complete is Ph.D. Admission for the 2020-21 batch. Along with this, the admission to the MA Programme is also likely to be completed in the month of October, 2021. The University has completed its 4th and 6th Semester teaching without disruption, and the ongoing 2nd Semester teaching will also be completed in this month.

- 4. The University has introduced the following six new programmes in the Academic Session 2021-22.
 - a. BA Hindi (Honours) Integrated 4 yrs programme
 - b. Masters of Public Health(MPH)

- c. MVoc in Tourism and Hospitality
- d. MA in Archaeology and Heritage Management(MAHM)
- e. MA in Conservation, Preservation and Heritage Management(MCPHM)
- f. Integrated MA-PhD (IPHD) in Human Ecology.

The University has received 1105 applications of foreign students from ICCR for admission to various UG/PG/PhD programmes in this Academic session. A total of 06 applications from foreign students belonging to various countries such as Mynamar, Zambia, Afghanistan, Vietnam, Palestine, Malawi, Botswana, have been accepted for various BA/MA/Ph.D. programmes and the admissions are still in process due to extension in admission process by ICCR till December,2021. Hence, the number of foreign candidates getting admitted in UG/PG/Ph.D. programmes is likely to increase in future.

- 5. The Training and Placement Cell of the University has played a key role in campus placements and internship during these difficult times. Apart from this, the University has associated with the Ministry of Labour and Employment to assist its students to upgrade latest technical skills with the help of associated partner Microsoft. Some of the prominent companies which have visited the Company are Planet Spark, Zomato, Study Room, Byjus, HCL Foundation, Outlook Group, Flipkart, Decathlon, Azim Premji Foundation, Niti Aayog etc.
- 6. The University has also initiated work with regard to the implementation of the National Education Policy. A Committee has been constituted to deliberate on the National Education Policy and the same has carried out two meetings on 05.08.2021 and 19.8.2021 and the third meeting has also been scheduled.
- 7. The University will soon inaugurate its first incubation center, Atal Incubation Centre in its Campus which will provide ample entrepreneurship opportunities to the students and incubates.
- 8. The School of Heritage Research and Management (erstwhile known as DIHRM) has been merged with Dr. B.R. Ambedkar University Delhi. This school will add value to our existing courses by enriching the curriculum of the University. The University has appointed Prof. Radharani Chakravarty as Dean of the School of Heritage Research and Management.
- 9. The University carried out Covid Vaccination drive at its three campuses viz. Kashmere Gate Campus, Karampura Campus and Lodhi Road Campus for its students, faculty members, staffs and also for general public, in coordination with the concerned District Officials.
- 10. The University has initiated the process of Quality Certification i.e., ISO 9001:2015(Quality Management System applicable to the education system). A Committee of 39 members (teaching and non-teaching) has been constituted to carry out the modalities of the certification in consultation with the Ministry of Electronics and Information Technology. The Dean (Planning) along with the Director, IQAC are jointly working on this.

Agenda 24.1 : Confirmation of the Minutes of the 23rdMeeting of the Academic Council held on 23.04.2021

The minutes of the 23rdmeeting of the Academic Council held on 23.04.2021, were circulated among all the members vide forwarding No. F. No. AUD/26-3(2)/Gov./23rdAC/2021 dated 13.05.2021.

No comments were received from any of the members.

The Academic Council confirmed the minutes of its 23rdmeeting held on 23.04.2021.

Agenda 24.2 : Action Taken Report (ATR) on the decisions taken in the 23rdmeeting of the Academic Council.

Action Taken Report on the decisions taken in the 23rd meeting of the Academic Council held on 23.04.2021 was placed before the Academic Council vide (**Appendix-1**). It was observed that the country name in respect of one of the Students namely Mr. Ngawang Youtso (S193B0024) has been written as "Tibetan". The same was corrected as "Tibet" (China).

The Academic Council noted the same for record and action.

Agenda 24.3 : Matters arising out of the Standing Committee Research (SCR) as emanating from its 54th and 55th meeting held on 16.06.2021 and 21.06.2021.

Agenda 24.3.1 : To consider the matter related to the admission of Foreign Students for the admission cycle for Academic Year 2021-22

It was submitted to the Academic Council that the Standing Committee on Research in its meeting held on 16.6.2021 deliberated on the matters pertaining to the Foreign Student Admissions 2021-22. As deliberated, a total of 1098 applications were received from foreign students for admission to UG, PG and Ph.D. courses for admission during the Academic Year 2021-22, via the portal of Indian Council of Cultural Relations. The last date for screening the applications and submitting the selected ones on the portal was 30.06.2021.

As per guidelines laid down by the ICCR, the Council has linked all the Universities of repute on A2A Portal so that the applications of foreign applicants applying through ICCR lands directly to the university selected by the applicant. In the process, universities will be able to scrutinize the application and decide on the eligibility criteria on A2A portal itself. If found eligible for admission, the university can upload the offer of provisional admission letter mentioning the documentation required by student to get confirmed admission and other specific norms and condition of the university at the time of their reporting to University. University must ensure that subject offered by university to student along with date of reporting of student at university should be specified. In case of rejection, the university can select No to reject the application." In view of provisions laid down by the ICCR, it was decided to modify the policy of Ph.D. supervision to permit the addition of supernumerary seats to the number of Ph.D. students that can be supervised by each eligible faculty as per Clause 6.5 of the UGC regulations, 2016. The Committee further deliberated on the fact that since, the admission cycle for the academic year 2021 -22 will begin later this year, and the programme wise number of seats for Foreign Students has to be notified for the same, the admission cycle for the academic year 2020-21, which is under process will not be affected by the prospective admission of the Foreign Students in the 2021-22 cycle.

The Standing Committee on Research further deliberated on the matter in regard to the foreign admission in light of the following points:

- i) Norms to implement supernumerary seats
- ii) Supervisory capacity for supernumerary seats
- iii) Advertisement for students including Foreign Students for the admission calendar 2021-22
- iv) Admission calendar for Foreign Students
- v) Programme wise number of Foreign students seats to be advertised
- vi) Maximum Foreign students seats vis-a-vis AUD non-JRF stipend which is not more than10 per programme
- vii) ICCR admission calendar vis-a-vis AUD admission calendar
- viii) Admission criteria for Foreign Students

After due deliberations on the aforesaid points the Standing Committee on Research recommended the following:

- 1. Foreign Students seats for the academic session 2020-21 and 2021-22 will be considered as supernumerary seats.
- 2. Number of supernumerary seats for each programme in the sessions 2020- 21 and 2021-22 shall not exceed two (02)
- 3. Supervisory capacity for these supernumerary seats may be considered as follows, and over and above the seats determined by Clause 6.5 of UGC Regulations:

Professor: 8 Indian National students+ 2 Foreign Students Associate Professor: 6 Indian National+ 1 Foreign Student Assistant Professor: 4 Indian National+ 1 Foreign Student

- 4. The Chairperson, SCR and Dean (IAD) in consultation with the Dean Student Services will constitute a committee to prepare norms for the admission process for the Foreign Students to PhD programmes for future academic sessions.
- 5. The Chairperson, SCR and Dean (IAD) will suggest the Terms of Reference(s) for the committee.

The Minutes of the 54th meeting of Standing Committee Research (SCR) held on 16.06.2021 are placed at **Appendix-2**.

Decision : In exercise of the powers conferred under Section 24(1) (vii) of Act of the University, the Academic Council resolved to approve the

recommendations of Standing Committee on Research pertaining to the admission of Foreign Students for the admission cycle for Academic Year 2021-22. It was also recommended to change the nomenclature of the word 'supernumerary'.

- b. Foundation electives under South Asia in the world basket (1st semester) or open electives in any other semester in which electives are offered
 - i. Sanjhi Sanskriti aur Hindustani Kavita
 - ii. Swadhinta Andolan Ke Vaicjarik Jagat or Hindi
 - iii. Bhartiy Evam Vishva Sahitya

The SCAP also recommended that the School may arrange to develop Hindi language core courses (foundation compulsory courses) aligned to the basic orientation of its programmes and blend with the spirit of the programmes.

The above proposal is placed at Appendix-4.

Decision : The Academic Council after due deliberation resolved to refer back the proposal to Standing Committee on Academic Programmes to review the proposal to offer the foundation/compulsory courses in Hindi in all BA programmes, School of Global Affairs. The Academic Council also recommended not to include the nature of the faculty to be engaged as Course Coordinator in the course descriptions forwarded by the Schools.

Decision : In exercise of the powers conferred under Section 24(1) sub clause (vi) and (xiv) of Act of the University and Statute 12 (1)(a), the Academic Council considered and resolved to approve the course outlines of the BVoc Tourism and Hospitality for its 1st year programme (1st and 2nd Semester) to be offered by the School of Vocational Studies as recommended by the Standing Committee on Professional, Vocational and Continuing Education programmes (SCPVCE).

Agenda 24.5.3 : To consider the Course "Hindi for Business Practice" under General Education Component (GEC) for BVoc 2nd Semester submitted by Sol to be implemented with batch 2021-22 Admission Cycle

It was submitted to the Academic Council that the Standing Committee on Professional, Vocational and Continuing Education Programmes (SCPVCE) in its 18th meeting held on 18.08.2021 deliberated on the recommendations of the Board of Studies of the School of Vocational Studies (SVS) to consider the course "Hindi for Business Practice" under GEC for BVoC 2nd Semester submitted by the School of Letters (SoL) to be implemented with batch 2021-22 Admission Cycle.

The course is being introduced as a compulsory course and has been developed by the School of Letters (SoL) under the GEC for all four BVoc programmes currently on offer by the School in the 2nd Semester as approved in the 23rd Meeting of the Academic Council held on 23.04.2021. This course is inclusive of the diverse contemporary linguistic trends or multiple Hindis (popular in current usage in media and communication). The course would enable students from the vocational stream to interact with the professionals from different fields.

After due deliberations, the SCPVCE approve the recommendations of the Board of Studies of the School of Vocation to consider the course "Hindi for Business Practice" under GEC for BVoC 2nd Semester submitted by the School of Letters(Sol) to be implemented with batch 2021-22 Admission Cycle.

The Course "Hindi for Business Practice" under General Education Component (GEC) for BVoc 2nd Semester is placed at **Appendix-13**.

Agenda 24.5.4 : To consider the Programme Structure of MVoc in Tourism and Hospitality Management Programme

It was submitted to the Academic Council that the Standing Committee on Professional, Vocational and Continuing Education Programmes (SCPVCE) in its 18th meeting held on 18.8.2021 deliberated on the programme structure of MVoC Programme as per the requirement of Tourism and Hospitality Programme.

The proposed MVoc Tourism and Hospitality Management Programme has been conceptualised in a multidisciplinary context, taking both tourism and hospitality in a holistic and integrated approach. It emphasizes practical application, industry exposure and research-based study rather than only theoretical knowledge. This will enable students to inculcate skills for meeting the needs of the tourism and hospitality industry for employment. Post graduates from this programme will find opportunities in organised tourism and hospitality sector such as such as Travel agencies, Tourism operators, Airport Management, Tour managers, Travel consultants, Hotels and Catering industries as Manager, etc.

The programme is conceptualized based on the NEP 2020 recommendations for vertical mobility of UG students and as per the recommendations under NSQF and guidelines issued by the UGC. It will be executed in four semesters with a minimum of 02 years and a maximum of 04 years duration with a total of 120 credits (30 credits per semester) as per the UGC guidelines. The programme is pitched at the NSQF level 8 & 9. Students completing the 1st year of their studies successfully and intending to exit will be awarded Post Graduate Diploma (NSQF level-8) and on completion of the 2nd year will be awarded Master Degree (NSQF Level-9).

The Committee deliberated on the fact that that programme could focus more on creating spaces for individuals with disabilities-both, for awareness in the service industry and in the student profile. The school follows the same reservation norms for students with disability as per other schools in the university. In addition, there are courses in SVS that do focus on creating inclusive spaces.

Gender roles and a larger discussion on marginalization within the industry could also be a point of consideration and discussion in the curriculum/courses. These could be in form of readings, workshops, awareness of policies related to ICC, interaction with the Equal Opportunity Cell and so on. In the BVoC programme, there are courses, especially in the General Education Component that do address issues related to diversity and inclusion. Further, induction of marginalised students into the programme also depends upon the admission policy of the university.

After due deliberations, the SCPVCE recommended to consider the Programme Structure of the MVoC Tourism and Hospitality Management as placed at **Appendix-14**.

Agenda 24.5.6 : To consider the 2nd year Courses of BVoc Accounting and Finance to be offered by School of Vocational Studies

It was submitted to the Academic Council that the Standing Committee on Professional, Vocational and Continuing Education Programmes (SCPVCE) in its 19th meeting held on 07.09.2021 deliberated on the 2nd year Courses of BVoc Accounting and Finance to be offered by School of Vocational Studies. After due deliberations, the SCPVCE recommended to consider the following courses:

i. Account Receivable (4 Credits)

This course will enable student to gain knowledge about the basics of Account Receivable management for the job of Accounting Executive. It will also focus on comprehending the details about the Sales journal, the contents thereof, and customer category and receivable particulars.

ii. Account Payable (4 Credits)

This course will enable students to gain knowledge about the basics of Account Payable management which is an important concept for the job of Accounting Executive. It will also provide information on ways to recognize relevant terminologies and documents related to the purchase booking process such as purchase order, purchase journal, invoice, material receipt report etc., and book the credit purchase in the books of accounts after having authorized by the senior / manager.

iii. Goods and Service Tax & Filling of Return (2 Credits)

This course will enable student to gain knowledge about the basics of 'Goods & Services Tax' (GST) for the job of Accounts Executive. Students will be able to acquire practical knowledge of the different procedures required under GST Act and rules such as Registration, Filing of Returns, availing Input Tax Credit, TDS (Tax Deduction at Source for Government Buyers) compliance, Refunds and other documentation requirement.

iv. Internship- Accounts Executive (8 Credits)

As a part of the internship, students will go out on training for 30 days after the completion of the theory syllabus of the semester. During the internship, they will be exposed to the practical aspects of the skills that they learned in the course. The main objective of the internship is to help students in developing their practical skills and practical knowledge. It aims to familiarize students with the functioning of Account Payable or Account Receivable and Goods & Service Tax & Filling of Return.

v. Payroll Function And Management (4 Credits)

This course will enable students to gain knowledge about the basics of payroll function and management for the job of Accounting Executive. The course goes through the process of preparing and calculating payroll. The course also includes the controls needed and the pre-checks necessary to make sure correct data is used for the calculation of payroll.

vi. Legal Framework on Corporate Laws (4 Credits)

This course will enable students to gain knowledge about various Corporate as well as other laws that govern the organised corporate sector in India and develop the ability to address basic case-specific and application-oriented issues. The various topics covered in the course are the Company Act 2013, Law of Partnership, Limited Liability Partnership, Law on Informational Technology and Law relating to environmental pollution and protection.

vii. Managing Statutory Compliances (2 Credits)

This course will enable students to gain knowledge about the basics of Managing Statutory Compliance for the job of Accounts Executive. Students will be able to understand the steps involved in filing of returns and maintaining records of the same for audit purposes. They will also be able to understand the preparation and submission of periodic reports related to tax payments to senior/ manager.

viii. Internship- Accounts Executive 2 (8 Credits)

As part of the internship, students will go out on training for 30 days after the completion of the theory syllabus of the semester. They are exposed to the practical aspects of the skills that they learned in the course. The internship aims to familiarize students with the functioning of Payroll and Statutory Compliances. Further, the internship aims to serve as a medium to acquire practical knowledge of the different procedures under GST Act and Rules Such as Registration, Filing of Returns, availing Input Tax Credit, TDS (Tax Deduction at Source for Government Buyers) compliance, Refunds and other documentation requirements.

The Committee on SCPVCE further recommended the following:-

- For the course on 'Legal Framework on Corporate Laws', it was suggested that the progression could be reworked in the following sequence: sole proprietorship, association of persons, partnership and company. The legal and the tax progression of each of this are different and it would be helpful for students to see the progression.
- Some contemporary Indian authors could be included as reference in some of the courses.
- There are several books on best practices related to accounts. A separate heading could be created that focuses on best practices.
- Could consider using diverse audio-visual sources for discussions.
- A consolidated document that maps assessment across courses would be helpful.
- Decision : In exercise of the powers conferred under Section 24(1) sub clause (vi) and (xiv) of Act of the University Statute 12(1)(a), the Academic Council considered and resolved to approve the 2nd year Courses of BVoc Accounting and Finance to be offered by School of Vocational Studies as recommended by the Standing Committee on Professional, Vocational and Continuing Education programmes (SCPVCE). The Academic Council also recommended that the nomenclature of the 4 credit course "Legal Framework on Corporate Laws" be changed to "Legal Course of Business" or "Corporate Laws". The Academic Council authorized the Vice Chancellor to approve the changed nomenclature.

Agenda 24.5.7 : To consider the proposal for Change of Credit Allocation for Discipline Specific Electives in BBA Programme

It was submitted to the Academic Council that the Standing Committee on Professional, Vocational and Continuing Education Programmes (SCPVCE) in its 19th meeting held on 07.09.2021 deliberated on the proposal for Change of Credit Allocation for Discipline Specific Electives in BSA Programme.

The proposal relates to increase in credit allocation of discipline specific electives from 2 credits to 4 credits each. The student would be required to choose two Discipline Specific Electives from the Electives offered at SBPPSE worth 4 credits each, one in Fourth Semesters and the second in Sixth Semester of SBA Programme. This will result in increase in the total credits of the program from 134 credits to 138 credits. The revised programme structures are as under:

Agenda 24.5.8 : To consider the proposal for courses to be offered in Third and Fourth Semester of BBA Programme

It was submitted to the Academic Council that the Standing Committee on Professional, Vocational and Continuing Education Programmes (SCPVCE) in its 19th meeting held on 07.09.2021 deliberated on the following courses to be offered in Third and Fourth Semester of BBA Programme.

Semester 3

i. Public Policy and Social Sector Reforms in India (4 Credits)

This course aspires to provide an in-depth understanding of the need of the state intervention in ensuring that its citizens are not deprived in achieving basic rights for an equitable society. Students will be exposed to the theoretical and field study to understand the implementation of public policies in the pursuit of distributive justice, in a welfare state like India. After analysing how public policies are conceptualised, formulated, and implemented, this course would focus on how public policies in India are working in social sector reforms.

ii. Human Resource Management (4 Credits)

This is a comprehensive course to understand how to manage people in organizations. The course is designed to acquaint the general management student with the core processes of the human resource function which are talent acquisition, development, performance management, reward and compensation cycle.

iii. Financial Management (4 Credits)

This course is foundational in nature as the different modules discussed in this course would subsequently be offered as full-fledged electives in the semesters to follow. It is essential for having a good grounding in finance and helps to enable the participants to make optimal utilization of firms' financial resources. The course is model-based and IT driven and emphasises on learning through corporate insights and interactions, assignments, presentations and projects.

iv. Quantitative Methods in Management (4 Credits)

This is a foundation course on quantitative methods for undergraduate students of business administration that emphasizes model building as a foundation for rational decision making, problem solving across disciplines and functional areas. The course will focus mainly on linear optimization models and will discuss the theoretical and practical aspects of the topics linear programming and its extensions including transportation and assignment problems, integer, zero-one and goal programming; project management methods, queuing and game theory. The course will also expose participants to the Microsoft excel interface for problem solving.

v. Foreign Language- Spanish - I (2 Credits)

The course will focus on four different aspects of the language--Reading, Writing, Speaking and Listening ability of the participants. It will cover these aspects with reference to cultural sensitivity and cross cultural issues. It will enable students to employ Best Practices while addressing Business clients of Spanish speaking countries.

vi. Field Immersion-Rural connect/NGO (2 Credits)

This course aims to make participants aware of the various social and economic issues and challenges faced by the people in the rural parts of India, as well as the marginalised sections of the society. It is designed to sensitize students with the emerging socioeconomic concerns of society and gain insights into the objectives, roles, responsibilities, accountability and delivery system of various organisations working towards business in rural India or NGOs engaged in the task of serving different sectors. It will provide an opportunity for participants to work with an organisation (rural space) or an NGO and create a platform for exchange of ideas, choice of appropriate managerial interventions and action learning.

Semester4

vii.Business Research Methods (4 Credits)

The course will focus on the study of approaching research questions in business. The objective of the course is to develop an understanding of different research methods, research tools, data collection techniques and interpretation of data followed by enhancing their ability to write a research report. It will also enable students to explain the plurality in research perspectives by adopting interdisciplinary research methods.

viii. Operations Management (4 Credits)

The objective of this course is to introduce issues related to design, planning and control in the domain of operations for manufacturing and service organizations. With this course the participants will be introduced to the fundamental elements of operations management. It will include modules on operations strategy, quality management, and inventory management demand forecasting, process and capacity management, facility layout and locations decisions and scheduling.

ix. Foreign Language-Spanish 2 (2 Credits)

The objective of the course is to train the students for exchanging information, making basic conversations and answering queries in case of need. The course will focus on four different aspects of the language---Reading, Writing, Speaking and Listening ability of the participants. It will cover these aspects with reference to cultural sensitivity and cross cultural issues. It will enable students to employ Best Practices while addressing Business clients of Spanish speaking countries.

x. Digital Marketing (4 Credits)

This course provides an opportunity for participants to learn about marketing in the digital world. The objective of the course is to examine how digital tools, such as the Internet, smart phones, and 3D printing are revolutionizing the world of marketing by changing the roles and practices of firms and consumers.

xi. Distribution and Supply Chain Management (4 Credits; Discipline Specific Elective)

This course would help participants to develop an understanding of objectives, elements and issues related to the distribution channels and supply chains. Various concepts and methods for the design, control, operation, and improvement of distribution channels and supply chain systems will be discussed.

xii. Gender and Entrepreneurship (4 Credits; Discipline Specific Elective)

This course aims to address the gender gap in entrepreneurship and strategies needed to fill this gap. It will begin with the need to understand the

differentiation between sex and gender, analyses how gender is constructed and lived up through families and other social institutions. It then studies the concept of entrepreneurship and the marginalities of women and third gender people in both developing and developed nations. It seeks to understand the institutional barriers and glass ceiling effects in entrepreneurship. Through case studies and global examples, students will learn about policy initiatives and civil society intervention. This course will conclude about strategies needed to close this gender gap which would pave way for promoting gender empowerment.

The Committee on SVPVCE further recommended the following:-

- A question was raised regarding the rationale for the inclusion of Spanish language in the programme. It was appraised to the members that the rationale for including the Spanish language for the BBA programmes as the language is most widely spoken languages among the European. Additionally, in most of the emerging markets in Latin America, Spanish is the language mostly used. The initial plan of the school was to offer both Chinese and Spanish language to students. However due to the pandemic, it was not feasible. Next, year, the school may consider offering both languages.
- The courses should focus on creating more inclusive work spaces for including diverse genders, disability and so on. Issues of ethics could be included, for example, Case study of Byjus etc.
- With respect to introducing Coursera course as MOOG course on digital marketing - it would be helpful to check how the courses of Coursera map out in comparison with the AUD assessment structure and timeline.
- The content of the course on 'Public Policy and Social Sector Reforms in India' maybe beyond the time that would be required to transact the course within a semester. Keeping in view of the content load for a 4 credit course, it was suggested that some sections could be reduced. Some of the content could be transacted via assignments or field based engagement keeping in mind concepts of equity, justice, democracy as a core.
- Decision : In exercise of the powers conferred under Section 24(1) sub clause (vi) and (xiv) of Act of the University and Statute 12(1)(a), the Academic Council considered and approved the proposal for courses to be offered in Third and Fourth Semester of BBA Programme as recommended by the Standing Committee on Professional, Vocational and Continuing Education programmes (SCPVCE). The Academic Council also recommended that the course on Operation Management(4 credits) in the BBA(4th Semester) may be substituted with the course on Production Management, as the Operation Management is a vast course and the students will find it difficult to handle the course considering the quantitative skills required in the subject. The Academic Council authorized the Vice Chancellor to approve the revised course.

Agenda 24.5.9 : To consider the proposal for courses to be offered in Third Semester (Module IV) of MBA IEVD Programme

It was submitted to the Academic Council that the Standing Committee on Professional, Vocational and Continuing Education Programmes (SCPVCE) in its 19th meeting held on 07.09.2021 deliberated on the following courses to be offered in Third Semester (Module IV) of MBA IEVD Programme. After due deliberations, the Committee recommended to consider the following courses:-

i. New Venture Establishment and Management (2 Credits)

Building on the understanding developed of entrepreneurship in general and the entrepreneurial mind set in particular alongside the ideation process, the next step of feasibility is explored and established in this course. After due appreciation of the various risks, the legal aspects and financial challenges, the final business model is sought to be built.

ii. Data Visualisation and Analytics (2 Credits)

Visualization is increasingly important in this era where the use of data is growing in many different fields. The objective of the course is to develop an understanding of incorporating visualizations to make sense of data and interpret charts and graphs. Secondly, the course will expose students to develop questions from visualizations. Thirdly, the course will introduce application of analytical tools to solve business problems and make predictions for the future.

iii. Digital Marketing for New Ventures (2 Credits; Elective)

This course provides an opportunity to participants to learn about marketing in the digital world. The objective of the course is to examine how digital tools, such as the Internet, smart phones, and 3D printing, are revolutionizing the world of marketing by changing the roles and practices of firms and consumers.

iv. Sales for Founders (2 Credits; Elective)

This course focuses on imparting the knowledge and skills required for creating and managing the revenue generating arm of the venture. It will expose students to issues relevant to selling in B2C as well as B2B domain. They will also understand the intricacies of managing traditional and modern retail business as immediate customers of any organization which is marketing its products and services to retail as well as institutional customers

v. Skill Based Programme IV (1 Credit; Workshop/Seminar)

The course will cover three main aspects namely; quick prototyping; revenue and financial modelling and developing a unique startup path for the programme candidates. Each subject shall be dealt with separately through conducting a workshop/ seminar and would encourage the participants to

engage with active learning, interactions and exposure to real-life case studies.

Matters for Information

Agenda 24.18 : To report the matter pertaining to the review of grades of MPhil Dissertation of Ms. Priyanka Nirwan student of MPhil Women's and Gender Studies, School of Human Studies

Ms. Priyanka Nirwan (Enrollment No. S184CWG04) student of MPhil Women's and Gender Studies, had appealed the School of Human Studies (SHS) to review her grades of MPhil Dissertation. The student had reported alleged procedural lapse and sent a request to the school on June 25th, 2021 for re-evaluation of her MPhil Grade B plus. The appeal filed by the student was discussed in the emergency RSC (Research School Committee) meeting of SHS, held on 1st July 2021 wherein, following observations were made:-

- 1. The committee observed that the procedural lapse on the part of the school that the student has put forward is not an intentional or inordinate delay, but it was an extra ordinary and difficult time of Covid-19 Pandemic and therefore it is not the basis on which re-examination can be warranted.
- 2. Apart from RAC members and supervisor, the student's dissertation was examined by two independent experts (one internal and one external) and the examiners had given the satisfactory reports after which the viva voice was conducted and graded and there doesn't seem any delay in that process. Therefore, there is no reason for asking for re-evaluation as it has been independently evaluated by two experts and also there is no provision in the MPhil Research regulations 2017 for revaluation of submitted dissertation after via-voce. Hence there will be no change in dissertation grade i.e. B plus.

The minutes of the RSC were further deliberated by the Chair, SCR, wherein the Chair SCR observed that i) there is no provision in the M.Phil Research Regulations 2017 for revaluation of submitted dissertation after viva voce. Hence, there will be no change in dissertation grade i.e., "B+" ii) As per the submitted time line, all examiners report of dissertation process of viva-voce did take longer than expected time because School Dean, office staff, the examiner, supervisor of the student and the student (Priyanki Nirwan) were all down with Covid during the month of April and May, 2021. Hence, there is no procedural lapse in the matter of Ms. Privanka Nirwan.

The recommendations of the Research Studies Committee (RSC) and the observations of the Chair, SCR were approved by the Competent Authority.

Agenda 24.29 : To consider the extension of AUD stipend for Non- NET PhD students

It was submitted to the Academic Council that the University provides minimum financial support to MPhil and PhD students @ 5000/- and 8000/- per month from academic year 2012. After a detailed discussion on status of stipends of AUD PhD students and in pursuance of the 27th meeting of the Board of Management dated 30th September 2019, it was decided to enhance the stipend to 10,000/- and 16,000/- per month for MPhil and PhD students respectively as stipend to the research studies students- MPhil and PhD who are not covered under UGC, ICSSR or other scholarships or fellowships.

As per the present PhD Regulations, the normal registration period is for five years and our present coverage under this scheme is only for three years. It is proposed that the coverage may be extended to the full tenure of PhD. Several other Universities have instituted mechanism to support their research scholars throughout this registration period. Some of the other universities (Delhi University and Banaras Hindu University) indicate that they are providing stipend till 4 years, but these are connected to old UGC regulations in which maximum PhD registration normally may be 5 years.

The proposal of extending the stipend till 4 years for now and for constituting a Committee to explore the possibility of extending the non-NET stipend till the full registration period, as per the AUD PhD Regulations, 2021 keeping in view the welfare of the University PhD scholars, was placed before the Academic Council for consideration and deliberations.

Decision : In exercise of the powers conferred under Section 24(1) sub clause (xiii), the Academic Council considered the matter and resolved to approve the extension of AUD stipend for Non- NET PhD students and to constitute a Committee to explore the possibility of extending the non-NET stipend till the full registration period, as per the AUD PhD Regulations, 2021 keeping in view the welfare of the University PhD scholars.

The Fellow, with the consent of the guide/head of department, may assist the university/institution in its academic work, including tutorials, evaluation of the test papers, laboratory demonstration, supervision of fieldwork, library activities like group seminars and symposia, provided such work is not likely to hinder the research programmes on hand. The total amount of time to be spent on such activities should not exceed ten hours a week.

Based on the above and considering similar assistantships in other Universities and internal consultations, the R&C Division proposed the Academic Work Assistance by PhD Scholars at Dr.B.R. Ambedkar University Delhi. In principle the same has been approved by the Vice Chancellor.
