The students are required to bring their ERP course registration form duly signed and stamped by the School office for the issuance of fee Receipt/Challan Form, between 10.00 a.m. to 4.00 p.m, Monday to Friday (except holidays) as per the schedule.

The last date of re-enrollment in the current semester is 30th April 2018. No request will be considered after this date. In case the student does not get re-enrolled, the semester in which the student has been de-enrolled will be a zero semester.

Accordingly, the fee is to be deposited by Swipe/Point sale Machine through Debit / Credit Cards at the counter established as per the details below: Kashmere Gate Campus (Student Services Division) & Karampura Campus (Student Services Division), Lodhi Road Campus (SES Office). Please note that payment by cheque will not be accepted.

*The students can also pay their fees online (through ERP) / Demand Draft and Debit/Credit Cards (only for those who have done the course registration).

The students who have availed fee waiver in Monsoon semester 2017 will continue to get the fee waiver in the current semester. However students applying for the first time for fee waiver will be required to submit the Income Certificate issued (in the current financial year) by the Sub-Divisional Magistrate at the time of payment of fees to avail the exemption based on the University's fee waiver policy.

* Facility of online(ERP) payment of semester fee will be available only till 09th February, 2018.
