## **CORRIGENDUM**

## Clarification regarding Technical Bids opened on 11.01.2018

Name of Work: NIT for Providing Security Services in various campuses of Dr. B.R. Ambedkar University Delhi

Tender Evaluation Committee (TEC) has observed that all the bidders who have submitted bids against e-tender (Id: 2017\_AUD\_142072\_1) No. AUD/1-10(118)/Admin/2017-18/security/550 dated 15.12.2017 for providing security services at Dr. B.R. Ambedkar University Delhi, have not submitted complete details duly supported by the documentary evidence regarding works awarded to them during last 3 years. Some bidders have either submitted the offer letters or performance reports not duly supported by the Work Orders or/and Agreements in terms of Clause 3.1.3 and Note-2 to Appendix I of Form 7.

- 2. In the interest to evaluate and decide the Tender in a fair and transparent manner, the Tender Evaluation Committee extends <u>last</u> opportunity to all bidders to submit following documentary evidence in support of their claims submitted/uploaded (on or before 08.01.2018) in the Forms-6 and Form-7 of Appendix I of above said e-NIT:
- (i) Duly attested copies of Work Orders or/and Agreements of the works awarded during last 3 years (on or after 01.01.2015) only (as per Clause 3.1.2).
- (ii) Documents at serial no. (i) above should specifically indicate number of security personnel deputed, date of start of contract, period of contract (should be for more than 9 months as per Clause 3.1.3 of NIT). Please do not submit documents for contracts which are for less than 9 months and wherein no. of security personnel is less than 10 (as per Eligible Assignments as defined in Clause 3.1.3 of NIT).
- (iii) Performance certificate, offer letters, letter of intent, empanelment letters, emails, extension letters etc. <u>not supported</u> by the copies of Work Orders or/and Agreement(s) will not be considered for evaluation and will be summarily rejected.(Clause 3.1.4)
- (iv) This corrigendum is being issued for seeking clarification only in documents already submitted/ uploaded in Form-6 and Form-7 of the Appendix I, as on last date (08.01.2018) of submission of e-bids. Therefore, any document in addition to details furnished/ uploaded on as 08.01.2018 shall not be considered for the evaluation of the e-tender. Documents in support of other criteria of eligibility submitted now in addition to what was submitted / uploaded as on 08.01.2018 will not be considered.
- 3. Therefore, all bidders are advised to submit documentary evidence, if they so desire and opt, in support of above clarification <u>in sealed cover</u>, with in one week of publication of this notice on website (AUD and e-tender) i.e. upto 07.02.2018. All **sealed covers** may please be forwarded to the Tender Evaluation Committee (TEC), C/o Administration Division, Room No 6, Dr. B.R Ambedkar University Delhi, Lothian Road, Kashmere Gate, Delhi-110006.
