TERMS & CONDITIONS OF CONTRACT FOR SUBMISSION OF TENDER / QUOTATION

- 1. The offer in sealed envelope from OEM/Authorized supplier/distributors shall be addressed to the Registrar, Dr. B.R. Ambedkar University, Delhi, Plot No.13, Sector-9, Dwarka, New Delhi 110077.
- 2. The AUD will not be responsible for late receipt of any quotation (i.e. after due date) the same will be not be entertained. The quotation will be accepted up to 3.30 pm on or before **09-03-2012** and it will be opened on the same day at 04.00 pm in the presence of participating tenderer or their authorized representatives. (If available). In the event of office being closed due to any reason whatsoever on the proposed date of opening of tender /quotation, the quotation will be opened on the next working day at the scheduled time without giving any notice).
- **3.** OEM/Authorized supplier/distributors are requested to enclose Photostat copy of the letter/certificate of their manufacturer appointing them as authorized distributor for marketing their product.
- **4.** Attach all technical details, literature, catalogue etc along with quotation.
- 5. Rates of battery should be quoted for 3 Year Warranty/Guaranty from the installation date.
- **6.** Each page of the offer is to be signed and stamped by the tenders and prices should be indicated in figure and words in Indian currency.

- **8.** AUD reserves the right to accept or reject any or all the quotation(s) in full or part without assigning any reason. The decision of the AUD in this regard shall be final and binding on all. - **10.** No advance payment will be made.
- 11. After sales service The supplier should have to provide after sales service at **free of cost** in Warranty/Guaranty period at AUD site.
- 12. The offer should be for the reputed brands of item and detail specification should be furnished for each items.

- **18.** DISPUTE SETTLEMENT: All disputes arising out of this contract shall be referred to the sole arbitration of the Bharat Ratna Dr. B.R.Ambedkar University, Plot No 13, Sector 9, Dwarka, New Delhi 110077; The venue of arbitration shall be NEW DELHI (INDIA).
- 19. The Vendor should quote buy back price of 56 nos. of old 12V, 28AH SMF batteries and need to remove from the premises of AUD at his own price. The vendor should have to replace the old battery & install to new one. The AUD will not pay any additional payment of detaching old & installation of new Batteries.
