- 1. Late receipt of bids (i.e. after due date and time) will not be considered. Authorized representatives of the bidders may participate in the tender opening committee meeting, in case they wish to do so.
- 2. Rates must be quoted in figures & words in INR with all levies and taxes i.e. Sales Tax, VAT, Service Tax, etc as per schedule given in the price bids.
- **3.** Earnest Money Deposit (EMD) of Rs. 7,000/- (Rupees Seven thousand only) in the form of crossed demand draft/pay order drawn in favour of Registrar, Ambedkar University, Delhi shall be enclosed with the quotation. The EMD of unsuccessful tenderer will be returned after completion of the tender process on request. Quotation received without EMD shall summarily be rejected.
- 4. Technical details, literature, catalogue etc. must be attached along with the quotation.
- 5.
