Subject: Guidelines for Control of Malaria, Dengue & Chikungunya

As we all are aware, during and after the rainy season, there is high prevalence of Malaria, Dengue & Chikungunya and other mosquito borne diseases. In order to control and prevent the Malaria, Dengue & Chikungunya outbreak and other mosquito borne diseases on the Campus(es). The Do's and Don'ts on the above subject are hereby reiterated for the reference and support of Students/Faculty and Staff.

Do's

- Keep all the water containers/overhead tanks etc. properly covered.
- Dry all the desert coolers and containers once a week.
- Change the water of indoor plants every week.
- Pls inform Caretaker and Security Supervisor of respective Campus for prompt action for removal
 of water logging and control of mosquitoes breeding, if any.
- · Regularly cleaning of roof of the buildings in coordination with E&M Unit.

Don'ts.

- Ignorance towards water logging in any amount.
- Dumping any kind on construction material i.e drums, buckets, water tanks etc. in open OR without proper cover.
- Store water into pots/vase indoor plants from more than one day.
- Don'ts leave water in desert cooler when not in use. Water should be chanced on daily basis, if
 in used.
