General Conditions

1. Fee for foreign students (as per guidelines in the Bulletin of Information of the admission in which admitted.
2. Payment through ERP (Online):-Log in to your ERP account & click on fee pay option and follow the instructions.
3. Fee to be paid by student as per approved fee for the academic year in which student is enrolled. Repeater to pay the fee as per fee structure of the year in which admitted.
4. Date of De-enrolment shall be 28th June 2022. If student wishes to be considered for re-enrolment again, he/she will submit an appeal for re-enrolment mentioning the reason for non payment of fees to the Dean of School concerned.
5. The students who have availed fee waiver in Monsoon semester 2021 will continue to get the fee waiver in the current semester. However students applying for the first time for fee waiver will be required to submit the Income Certificate issued (in the financial year 2021-22) by the Sub-Divisional Magistrate at the time of payment of fees to avail the exemption based on the University's fee waiver policy. The last date by which the fee waiver can be availed is 27th June 2022.
