1. Fee for foreign students will be as per guidelines in the of Bulletin of Information of the admission year.
2. Payment through ERP(Online):-Log in your ERP account & click on fee pay option and follow the instructions.
3. The last date of re-enrolment in the current semester is 30th September 2021. No request will be considered after this date. In case the student does not get re-enrolled, the semester in which the student has been de-enrolled will be a zero semester.
4. The students who have availed fee waiver in Monsoon semester 2020 will continue to get the fee waiver in the current semester. However students applying for the first time for fee waiver will be required to submit the Income Certificate issued (in the current financial year) by the Sub-Divisional Magistrate at the time of payment of fees to avail the exemption based on the University's fee waiver policy. The last date by which the fee waiver can be availed is 12th September 2021.
